

Western Australia Gas Services Information 2021-22 AEMO Final Budget and Fees

June 2021

Executive summary

This document sets out the Western Australia Gas Services Information budget and fees for 2021-22. AEMO operates the GSI to provide a Gas Bulletin Board and WA Gas Statement of Opportunities to provide information on WA gas transmission, storage and demand.

AEMO operates on a cost recovery basis as a company limited by guarantee under the Corporations Act (2001). AEMO recovers all operating costs through fees paid by participants.

In 2021-22 operating expenditure is marginally lower, reflecting only minor changes in expenditure levels of various cost factors. The GSI recovery is to increase to \$1.752 in 2021-22 from \$1.115m in 2020-21, as the 2020-21 Revenue Requirement included a return of surplus funds of \$0.7m from previous year.

AEMO is actively seeking to improve the transparency and rigour of its budget fees across all our functions and jurisdictions. This year, AEMO initiated early engagement with and sought feedback from a representative group of stakeholders on AEMO's draft budget and fees and capital projects alongside market consultation processes. Feedback from participants informed AEMO's final budget adoption. AEMO intends to continue and refine this approach in future years.

For the GSI specifically, AEMO is required to submit its allowable revenue and forecast capital expenditure to the WA Economic Regulation Authority (ERA) every three years.

AEMO's annual budget sets out the amounts that will be charged under the GSI rules, 114. This report provides a view of the final WA GSI revenue and expenses for 2021-22.

2. Western Australia (WA) GSI

2.1 Fees

Purpose of this function

The GSI function includes the GBB (WA) and WA GSOO. The objectives of the GBB (WA) and WA GSOO is to ensure:

- Security, reliability and availability of the supply of natural gas.
- Efficient operation and use of natural gas services.
- Efficient investment in natural gas services.
- Facilitation of competition in the use of natural gas services.

Similar to the GBB on the East Coast, the WA GBB is an information website hub to provide flow information on gas transmission, storage, emergency management with supply disruptions, and demand in WA.

The WA GSOO is an annual planning document providing medium to long term outlook of gas supply and demand in WA, transmission and storage capacity.

Revenue Requirement and Fees

The GSI recovery is to increase to \$1.752 in 2021-22 from \$1.115m in 2020-21, as the 2020-21 Revenue Requirement included a return of surplus funds of \$0.7m which isn't applicable in 2021-22. Excluding the surplus return there is a slight decline in the budgeted revenue requirement.

Other notes

The current three-year ERA determination on <u>AEMO's allowable revenue and capital expenditure</u> covers the period from 1 July 2019 to 30 June 2022.

AEMO has enhanced its engagement and transparency on its fees in 2020-21.

Purpose of this function To undertake economic regulation and price setting, licencing and compliand monitoring for the Western Australian Electricity and Gas markets.		
Revenue Requirement	AEMO is required to recover the funding for the ERA from WEM market customers and generators and gas shippers (i.e. pass through recovery). Total expenditure budgeted by the ERA for the GSI function in 2021-22 is \$75k (-55% increase) (2020-21: \$166k).

Revenue Requirement	AEMO is required to recover the funding for the EPWA from WEM market customers and generators and gas shippers (i.e. pass through recovery), commencing from 1 July 2021. Total WEM revenue requirement budgeted from the EPWA in 2021-22 is \$160k.
