

# POC Systems Work Group No.4 Meeting Notes

#### 1. Key Outcomes

#### **New Protocols**

- AEMO presented the new protocol and interfacing methods presentation to the group outlining the proposed 'Push Push' solution created by the focus group and the details on how this solution will interoperate with the current 'Hokey Pokey' FTP.
- During this discussion a number of questions were raised which will require feedback from AEMO,
  - How will the eHub handle in flight transactions when switching (to manage contingency scenario) from Web Services to FTP? AEMO will document this process and feed it back to the group.
  - The proposed solution for notified parties does not offer the initiator the ability to choose to receive all the TACK's. The focus group had previously proposed that there was no need to receive all of the TACK's and decided only the rejections were needed to be sent from the eHub. However, a number of participants in the room raised the point that they would indeed need all TACK's (positive & negative). Therefore AEMO will provide the optionality for the participants to receive all or just the negative TACK's from the eHub.
  - As all participants will be transferring to the new schema on Dec 1 2017 shouldn't the eHub only support versions only from that version onwards as previous versions don't account for the new market? AEMO will investigate whether a technical validation should be added to the Ehub to reject previous versions and will report back to the group.

## **Multi Party Discussion Paper**

- AEMO provided an update to the group on the 'Multi Party' paper published by the focus group last week that was sent out to members for feedback. Noting that 2 responses where received by AEMO.
- The group then had an open floor discussion on the paper giving the group the opportunity to go into more details on the feedback provided and also provide further feedback in the room. During the discussions it was agreed by the group that the existing paper does not clearly outline the technical limitations of implementing a 'One to Many' solution on the existing ftp 'Hokey Pokey' protocol and that these should be included prior to sending to the B2B WG. There were also some questions raised around the approach AEMO was proposing to respond to the 2 members who provide feedback on the paper. AEMO was planning to respond directly to these members. But the group agreed that it would be more beneficial for the wider group to also be included in these responses. AEMO will therefore update the paper to include the technical limitations and its responses to the feedback received.

## 3. Other Business

- A member raised concerns around the timelines of the procedures, given the TDS is being published on the 23<sup>rd</sup> December and is only going through 1 round of consultation. The question in the room centred upon what happens if there is a major change in the procedures (TDS) between the 23<sup>rd</sup> December and the final determination on the 6<sup>th</sup> March, noting that industry testing starts in mid-August. AEMO took the action to raise to the B2B working group, to see if there is any channels of communications we can have between these dates to inform the SWG members of change earlier than the final determination.
- A member also raised the possibility of an additional report in MSATS that would provide a monthly view of transactions and there status for traceability. This was suggested to be needed in addition to the existing daily zip files. AEMO has discussed this internally and at this stage will not be progressing this further. However this could be raised in the LVI discussions if it seen as a high priority for the group.
- The group also discussed and agreed on an approach for determining the changes required on the LVI. A focus group will be formed and tasked to do this. The focus group will then report back to the wider group. The opinion being this will a more efficient approach than starting in the wider group first.
