

Unit Category Data – January to March (Q1) 2025 - Revised

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

- Proportions.
- Maximum number of units.

- The dates on which auctions will be held.
- Auction allocation and cancellation fees.

For 2025 Quarter 1 this information has previously been published by AEMO. In accordance with Clause 15.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2021/22 against costs incurred and determined that there was an under recovery. AEMO has therefore adjusted the auction expense fees for 2021/22 to return the difference in 2022/23. The original and revised auction expense fees for 2025 Quarter 1 are presented below.
