## 1. Welcome and Confirm Agenda

AEMO noted, while the Electricity Market Reform Bills have been delayed, it will still progress with aspects of the WAMRP not requiring legislative change.



## 2. Progress Update on Reserve Capacity Mechanism Phase 3 (RCM) Project

- AEMO (Andrew Thornbury) noted that the RCM3 project is now at 'Execution Status' with the three main stages being Key Interface Contracts, IRCR Calculations and Settlement Calculations.
- The testing environment will be made available to stakeholders at the appropriate stage in 2017.

## 4. Application Programming Interface (API) Principles

 AEMO (Mark Brodziak) presented the priority items for API development and asked stakeholders to review these offline and forward comments to AEMO.

#### 5. Application for Certification Demonstration

- The first design of the Application for Certified Reserve Capacity was shown to stakeholders in a 'live' demonstration.
- Stakeholder assistance/ feedback will be welcomed as the design progresses.
- Question Does this replace the existing spreadsheet and when will the web application be ready for use'?
  - Answer The new screen replaces the existing screen and spreadsheet. Participant IT teams can integrate spreadsheets or other systems using the API. The RCM cycle opens 1<sup>st</sup> May 2017, and the new screen is unlikely to be available then but all current data will be migrated to the new system when it is released.
- Question Can you request data from the web application?
  - Answer AEMO is providing an API and has indicated the areas it is planning to support. The web screen uses the same API as the external interface but not all features would be documented and available for external use. If there are other interfaces that are important to participants please provide feedback and AEMO can consider adding this to the supported external API.
- Question Can validations be performed within the application?
  - Answer There is validation in the screens and rule references will be provided to help guide participants.
  - ACTION: AEMO to advise stakeholders of the proposed mechanism and dates for market participant involvement in demonstration forums.
  - ACTION: AEMO to provide further demonstrations of functionality that have been completed.
- The web service/application visibility was requested as soon as possible by stakeholders.
