1. **DEFINITIONS**

Refer Schedule 2 for glossary and complete list of nomenclature and symbols, and other conventions in terminology adopted throughout.

2. REQUIREMENTS

Refer Schedule 1 for requirements for information storage, reporting, and broad requirements for the user interfaces to the application.

3 OUTLINE OF THE PROCESS

Following the end of the month, (utilising actual settlement data (metered or as allocated, from the metering database) and the AMDQ applicable at each location on the day in question), for each schedule for each day of the month:

- 1. for settlement run prior to the date of this procedure taking effect, determine total amount of uplift for a schedule = total ancillary payments for a schedule, otherwise read the total amount of uplift payments
- 2. determine AMIQ, applicable for each market participant
- 3. determine market participant effective forecast withdrawals and any residual AEMO demand forecast override
- 4. determine "surprise" quantities (GJ) for each market participant and AEMO
- 5. determine "congestion" quantities (GJ) for each market participant and the declared transmission system service provider
- 6. cap both positive and negative uplift rates to the corresponding average ancillary payments rates
- 7. Apportion total uplift (\$) from (1) into "surprise" uplift (\$) and "congestion" uplift (\$) and "common" uplift (\$) based on (4), (5) & (6)
- 8. Allocate "surprise" uplift (\$) from (7) to each market participant based on their "surprise" quantities for that schedule as calculated under (4)
- 9. Allocate "congestion" uplift (\$) from (7) to each market participant and the TPO for the schedule within the gas day based on the market participant and TPO quantities (GJ) from (5)
- 10. Allocate "common" uplift (\$) from (7) to each market participant based on their share of total V and D withdrawals, excluding compressor fuel gas

4. AMIQ QUANTITIES (GJ)

This section deals with the way in which AMIQ quantities are determined.

4.1 Determine Diversified AMDQ for each market participant

For the purposes of calculating uplift, all *authorised MDQ* held at a site and *AMDQ credit certificates* nominated to a site, must be adjusted to account for their diversity. This is achieved by multiplying the *authorised MDQ* allocated to a site and *AMDQ credit certificates* nominated to a site by the diversity factor specific to each site. However, *authorised MDQ* held at the hub and *AMDQ credit certificates* nominated to a hub do not need to be adjusted to account for their diversity. All these quantities must then be summed to a total figure for each participant at each close proximity injection point (which may be a single supply point, or a collection of supply points and is defined in defined in Appendix B of the Uplift Payments Procedures) as follows:

4.2 Apportionment of Tariff V Authorised MDQ (at Longford CPP) to Market Participants

4.2.1 An overview of the process



An annual allocation of Tariff V *authorised MDQ* is made available to *Market Participants* for use in supporting uplift hedges. This allocation is determined by pro-rating the block of Tariff V *authorised MDQ* to each *Market Participant* based on their share of the total Tariff V customer load in peak Tariff V demand days in the previous winter which are defined as the ten gas days, between 1 May and 30 September each year, with the highest system Tariff V load.

The annual allocation applies on the fifth business day of November each year, after it has been adjusted for change in Tariff V customer numbers between winter and the end of October. The change in customer numbers is as supplied for the determination of full retail contestability (FRC) fees.

The allocation is adjusted monthly on the fifth business day of every month other than November, based on the change in Tariff V customer numbers. The change in Tariff V customer numbers is as supplied through FRC fees. Figure 1 shows the process for annual (November) and monthly adjustments of Tariff V AMDQ allocations.

Figure 1 – Tariff V AMDQ allocations - annual and monthly adjustments




For every other gas day during the month, a daily adjustment is applied based on the estimated changes in customer numbers calculated as the net Tariff V customer transfers completed, plus any new sites received, less any site de-registrations received, since the previous gas day.

The daily adjustments are based on actual data for customer transfers, new and deregistered sites for Tier 2 retailers. As data will not typically be available for new and deregistered sites for Tier 1 retailers, they are ignored in the calculation, with an assumed negligible impact. This is then corrected at the beginning of each month to agree with the customer numbers associated with FRC fees sent by Distributors. This is shown in Figure 2.

4.2.2 Determination of Tariff V winter peak day loads and AMDQ allocations

Each Market Participant's Tariff V winter peak day load in GJ is determined on the fifth business day in November each year as follows:

A Market Participant's Tariff V winter peak day load for the period 1 May and 30 September of the current year equals the sum of that Market Participants' Tariff V winter peak day load on the top ten winter peak days during this period.

Each Market Participants' percentage share of the total Tariff V winter peak day load is then calculated as follows:

A Market Participant's percentage share of Tariff V winter peak day load equals that Market Participant's Tariff V winter peak day load divided by

the sum of all Market Participants' Tariff V winter peak day loads.

4.2.3 Annual Adjustment – On the fifth business day of November each year

On the fifth business day of November each year, each Market Participant's Tariff V AMDQ allocation is adjusted to reflect customer transfers between winter (as defined earlier) and the last gas day of October each year as follows:

A Market Participant's adjusted Tariff V AMDQ percentage share on the 5th business day of November is equal to:

that Market Participant's adjusted number of Tariff V customers at the end of October divided by the total adjusted number of Tariff V customers of all Market Participants at the end of October – Note that the adjusted number of Tariff V customers must be greater than or equal to 0.

Note that the number of Tariff V customers must be greater than or equal to 0.

4.2.4 Monthly Adjustment – Five business days after the end of every month (December current year to October following year)

On the fifth business day of each month from December of the current year to October of the following year, the % share of Tariff V winter peak day load is then adjusted for changes to customer numbers.

A Market Participant's adjusted Tariff V AMDQ percentage share on the 5th business day of each month where month ≠ November is equal to:

that Market Participant's adjusted number of Tariff V customers for the month divided by

the total adjusted number of Tariff V customers of all Market Participants for the month – Note that the number of adjusted Tariff V customers must be greater than or equal to 0.

4.2.5 Daily Adjustment – On every other gas day

On every gas day that is not the fifth business day of the month, a Market Participant's adjusted daily Tariff V AMDQ percentage share is calculated as follows:

that Market Participant's adjusted number of Tariff V customers for that gas day divided by

the total adjusted number of Tariff V customers of all Market Participants for that gas day – Note that the number of adjusted Tariff V customers must be greater than or equal to 0.

Note that the number of Tariff V customers must be greater than or equal to 0.

4.3 Determination of Injection Hedge and Agency Injection Hedge

A *Market Participant* can nominate part or all of their injections for use by another *Market Participant* to generate an uplift hedge. The allocations of injection towards generating uplift hedge will occur in two phases, the first will be to allocate all the injection towards the injecting market participant until they satisfy their total nominated amount. The second step will be to allocate the remaining injection amongst other market participants on either a "preference system" or a "prorate system".

This stage of the calculation is performed for each supply point, not each close proximity injection point.

Market participant X's scheduled injection is 30GJ, of which 20GJ is used towards satisfying its own injection hedge while the remaining 10GJ of scheduled injection is apportioned to market participants Y and Z resulting in 5GJ of agency injection hedge for each of the recipient market participants.

4.4 Determination of participants scheduled injection quantity not entitled to Ancillary Payments

For each *Market Participant* injecting at each injection point at the relevant close proximity injection point, the quantities of scheduled injection that have been used to generate an *injection and/or an agency injection hedge* are not entitled to *ancillary payments*. This is equal to:

4.8 Calculation of AMIQ

The AMIQ for a Market Participant is calculated by multiplying the sum of the uplift hedge determined under clause 4.5 and 4.6 for each close proximity injection point that the Market Participant injects from by the AMIQ profile nominated for the final (10PM) schedule of the gas day by the Market Participant to AEMO under NGR Part 19 Rule 211 (2A).

5. CALCULATION OF MARKET PARTICIPANT EFFECTIVE DEMAND FORECAST

This section deals with the way in which the forecast demand of a *Market Participant* will, for the purpose of uplift calculations, be adjusted over the day to reflect any AEMO demand forecast overrides.

8 APPORTIONING TOTAL ANCILLARY PAYMENTS TO COMMON, SURPRISE AND CONGESTION

This section details the manner in which total ancillary payments are apportioned to "common", "surprise" and "congestion" to be recovered through uplift payments made by Participants at each schedule. Note, that from 1 May 2008 total uplift payments for a schedule will equal the ancillary payment quantity for that schedule after the AP flip flop algorithm has been completed.

For the avoidance of doubt a positive uplift payment value represents a payment from a *Market Participant* to the market.

A positive ancillary payment amount should be allocated amongst positive EC and SC values. A negative ancillary payment amount should be allocated amongst negative EC and SC values.

8.1 Total ancillary payments and uplift payments (\$)

For settlement calculations pertaining to a date prior to 1 May 2008 total uplift Payment for a schedule is determined to be the aggregate of all Market Participants' ancillary payments at all injection and withdrawal points for a schedule as follows:

8.2 Uplift rate caps

The positive and negative uplift rates for each schedule should be capped to be no more than the corresponding average ancillary payment rates in that schedule. This prevents market participants from paying more than what they need to pay to fund the corresponding ancillary payments on a \$/GJ basis. The positive and negative average rates for ancillary payments are taken from the Ancillary Payment Functional Design v 8.2, section 8.5.7,

Where the positive average rate for ancillary payments is PAVAPR(S),

and the negative average rate for ancillary payments is NAVAPR(S).

Note: both rates will have **positive** values.

8.2.1 Determination of Initial Positive Uplift Rate Cap (\$/GJ)



Schedule 1. Requirements

- The application user must be able to submit an uplift allocation run by entering a gas date and a QTPO(S) for each schedule within that gas day and then initiating the run.
- The application must generate a unique identifier for each run and store this identifier in the
 Uplift database together with the gas day, the Q^{TPO}(S) and the date and time the run was
 submitted, and the information as listed below.
- It is critical that both AP's and uplift are calculated using exactly the same input data, such as metering, AMDQ, AMDQ credits etc (excluding TAP_(S) and TUP_(S) where these differ). If not, the results will be invalid and consequently the user needs to be notified by the application. Therefore, the uplift application must compare the check values for the validated energy transfer version id, and the check value for the validated AMDQ-AMDQ credits transfer version id, and notify user of results.
- the application must display the results to the user once the uplift allocation run is complete.
- All input data used in order to calculate uplift allocations must be retained in the Uplift database for auditing purposes. This data must be stored so that for each uplift allocation run it is possible to determine exactly what input data was used for the run.
- All output data must be retained in the Uplift database for auditing purposes. This data
 must be stored so that for each uplift allocation run data is recorded for each output
 noted in the table following associated with the run identifier.
- The outputs defined in the associated table are to be written to tables in the settlements database, and associated reports on the MIBB are to provide views into the tables, restricted for participants to that information relating to their own settlements only.
 - notifications and associated information are to be provided to the AEMO user of the application at the culmination of a process run
 - a view of all of the outputs is to be provided to AEMO

Schedule 2. Nomenclature

This schedule lists the inputs utilised by the uplift application, the sources of this information, and defines nomenclature for the functionality described in this document.

1. General relationships

In TMM/MCE, the operational scheduled quantities are by pipeline point.

- A physical MIRN is currently associated with each pipeline point.
- At present, participants enter nominations or offers against a pipeline point (physical MIRN) for both injections and controllable withdrawals.
- Supplier and demand point constraints (SDPC) currently apply to pipeline points.

- Tariff V withdrawals are stored by *Market Participant* who is FRO (i.e. host retailer) by day, across the system (NB it is calculated within the BMP by DB area).
- total injections at each system injection point are stored by physical MIRN (which corresponds to a pipeline point).
- injections allocated to a *Market Participant* by an allocation agent are stored by logical MIRN by market participant for the gas day
