This makes the Q4 2021 implementation date the preferred option as opposed to Q4 2020. Given the complexity and cost associated with such a change, it is an imperative part of the consultation process that the net benefits outweigh the costs in order to proceed with industry change. With the evolving development of the Life Support user guide and adoption of this process matures between participants, Origin believes the current process is fit for purpose.
