CRITICAL EXAMINATION OF PROPOSAL

1. DESCRIPTION OF ISSUE

AEMO proposes the following changes to the TSPR:

- Change the Queensland Gas Pipeline from a single direction pipeline to a bi-directional pipeline between Rolleston and Wallumbilla
- Change the backhaul service on the Queensland Gas Pipeline from Moura Wallumbilla to Moura Rolleston
- Include notional points Fairview, Westgrove and Gooimbah

3. OVERVIEW OF CHANGES

AEMO proposes the following changes to the TSPR:

- Change the Queensland Gas Pipeline from a single direction pipeline to a bi-directional pipeline
- Remove the backhaul receipt points at Fairview, Westgrove, Gooimbah and Rolleston
- Remove the backhaul delivery point at Wallumbilla
- Create new Rolleston backhaul delivery point
- Create new delivery zone DZ-05
- Create new notional delivery points Fairview, Westgrove and Gooimbah in DZ-05
- Create new southern forward haul segment FS-07 from RZ-03 to RZ-02 / DZ-05
- Create new southern forward haul segment FS-08 from RZ-02 / DZ-05 to DZ-06
- Create new delivery zone DZ-06
- Create new Wallumbilla forward haul delivery point in DZ-06


