# 1.1. Distributed Energy Resources Register Information Guidelines - 2019

Date of Notice: 29 January 2019

This notice informs all Registered Participants and interested parties (Consulted Persons) that AEMO is conducting a consultation on the development of Distributed Energy Resources Register Information Guidelines.

This consultation is being conducted under clause 3.7E of the National Electricity Rules (NER), in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.

#### Matter under Consultation

The matter for consultation is to develop Distributed Energy Resources Register Information Guidelines. These guidelines will specify, amongst other things, the details of the information that NSPs must provide to AEMO, as well as when and how the information is to be provided. Further details are provided in the Issues Paper published with this notice.

#### The Consultation Process

The consultation process is outlined below. Dates are indicative only and subject to change.

### Invitation to Make Submissions

AEMO invites written submissions on the matter under consultation, including any alternative or additional proposals you consider may better meet the objectives of this consultation and the national electricity objective in section 7 of the National Electricity Law.

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.



Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.

#### Meetings

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.

## Closing Date and Time

Submissions for this stage of consultation close at 5.00pm (Melbourne time) on 07 March 2019.
