#### 3. Notes

#### 3.1 Welcomes and Introduction

- AEMO provided meeting objective to run through AEMO's assessment of issues as intended to state in the final report.
- Acknowledged terms of reference.
- No additional agenda items raised.

# 3.2 Status update (slide 4)

 AEMO noted that the final determination and guidelines are being drafted ready for finalisation, and most decisions have been finalised.

## 3.3 AEMO final responses to key issues raised (slides 6–13)

- AEMO provided overviews of the major issues raised in submissions and the group discussed key issues
- Collection actors
  - Stakeholders reiterated concern about the role of installers and how this is controlled and managed. Requested that AEMO consider potential future states for the DER register following implementation.
  - AEMO acknowledged that compliance is an industry-wide challenge that the DER Register should support and is willing to consider potential future roles for the DER register.
  - AEMO was requested to consider the ability to provide retail customers with receipts of the DER record being confirmed. AEMO does not intent to do this currently.
- Third party databases and default data
  - NSPs raised some concern about the number of notifications they may receive.
  - AEMO noted that the default data should streamline and manage this.
  - NSPs do not want installers to be able to enable/disable inverter control modes and can
    accept the approach to receive notifications if devices without required control modes are
    installed. AEMO is proceeding on this basis.
- Third-party data submission
  - Some concern raised around the role of job numbers to enable access to DER records by third-parties, especially where pre-approved DER is installed. AEMO noted that we can support NSPs during the implementation stage to ensure this approach can work.
- Information Collection Process
  - o AEMO and the group discussed key issues raised.
  - AEMO supported the need to be clear about use cases in the final report.
  - Application developers keen to ensure visibility of how they can work with the system to support DER installers. AEMO will arrange a meeting with them to kick off this discussion, following the technical specifications and API development.
- Data validation



- AEMO noted the approach and the opportunity to increase the role of post-submission validation once the DER register is implemented. NSPs are welcome to provide additional ideas on what can add value here.
- Timing and time limitations
  - AEMO noted that the 20-business day period will commence from the date the DER installation (new or changed) is commissioned, or existing system decommissioned. This date will be editable by account-holders and NSPs.
  - NSPs expressed a desire to be able to reset account-holder access to a DER Record. AEMO will accommodate this.
- Post-installation setting changes
  - o AEMO provided overview of the potential future roles for the DER register.

## 3.4 Implementation Planning (slide 15)

- AEMO provided overview of planned next steps for the implementation planning.
- Stakeholders agreed that an implementation working group would be a good way to support the process (including communications and other activities).
- AEMO agreed that greater visibility of implementation activities would support all stakeholders. This will be provided online following the publication of the final documents.
