TasNetworks supports the reversion of the requirement to match Register ID with NMI Suffix, however, does not support the requirement to provide a mapping of Register ID to Datastream Suffix.
		TasNetworks expects that participants would currently have system logic that maps the NMI Suffix in the NEM12 file to the corresponding meter register MDM Contributory Suffix record as these have to match, so does not see any value in having to provide additional relationship mapping details.
		It is understood that AEMO also do not need such mapping details for their new 5MS MDM solution or for settlement purposes to map the NEM12 file with the respective meter register record based on the NMI Suffix. TasNetworks therefore question the need for MDP's to provide a register mapping guide.
