The changes being proposed are because of NER rule changes which have occurred requiring changes to AEMO's Retail Electricity Market Procedures.

Does it need to be modified? Is there a better alternative?	Unlike the FRMP there is no obligation to provide the DRSP with information on planned outages.
	The introduction of a PIN OWN specifically for DRSPs imposes a significant change to AusNet Services existing systems and processes. AusNet Services proposes that, like retailers, the DRSP should view planned outages via the DBs Website as per the current process with Retailers. Meter data already shows when a site is temporarily without supply and DRSPs would use this to reconcile outages noting they would still need to contend with unplanned outages.
Do you agree that the PIN should be provided to the DRSP by Retailers and Distribution Network Service Providers?	AusNet Services does not support the introduction of the PIN OWN for planned outage notification to the DRSPs, as per previous responses.
