

NOTICE OF FIRST STAGE OF CONSULTATION

National Electricity Rules - Rule 8.9

Reliability Forecast Guidelines

Date of Notice: 11 November 2020

This notice informs all Registered Participants and interested parties (**Consulted Persons**) that AEMO is conducting a consultation on its **Reliability Forecast Guidelines**.

This consultation is being conducted under clause 11.116.4(a) of the National Electricity Rules (**NER**), in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.

Matter under Consultation

AEMO is consulting to facilitate informed discussion and feedback by industry about the most efficient way to meet the objectives for 4A.B.4 in the NER.

In summary, the key proposals involve:

- Updating the Guidelines as appropriate to align with the Forecasting Best Practice Guidelines (FBPG). The publication of the FPBG occurred in August 2020, post release of the Interim Guidelines.
- Alignment of the Guidelines with the scope and purpose of the Forecasting Accuracy Report (FAR) and Forecasting Improvement Plan (FIP)

Further details are provided in the Issues Paper published with this notice.

Invitation to Make Submissions

AEMO invites written submissions on the matter under consultation, including any alternative or additional proposals you consider may better meet the objectives of this consultation and the national electricity objective in section 7 of the National Electricity Law.

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.



Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.

Meetings

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.

All submissions must be forwarded in electronic format (pdf or Word). Please send any queries about this consultation to the same email address.
