

A sharepoint site has been established for the Committee to facilitate collaborative roadmap development.





Roadmap format


- Roadmap format will be consistent with the industry-wide Regulatory Implementation Roadmap
 - Allows for future integration of the NEM2025 Implementation Roadmap with the Regulatory Implementation Roadmap
 - Familiar format for stakeholders and low barriers to access
 - Imparts significant information, but in a simple visual format
- Dependency mapping visualisation tool still being considered
 - Currently using Visio internally, filters/layers proving helpful

- RDC members requested to provide views on template and to prepare impact information for respective participant types








Round 2 workshops structure

Workshop Objective: To assess bundling, sequencing and prioritisation pathways as part of Roadmap development







Reference Material

- Outline of individual initiatives including: problem statement, objectives, scope, assumptions, dependencies and schedule
- Building upon the material shown during Workshop 1 and to be used as reference material for the final roadmap
- Workshop 1 Feedback included

Relationship Mapping

- Draft mapping accounting for all ESB and AEMO initiatives
- Relationships range from: Functional, Deadline, Sequencing (Design or Implementation / Operation), Policy, Trials, Technology (Base), Technology (Strategic)
- Provides a basis to identify bundling, sequencing and prioritisation pathways

Roadmap Walkthrough

- Draft roadmap building on the work completed to date
- Identification of project sequencing, bundling, timing including key milestones and alternative pathways
- Single pathway likely to be presented initially, alternative pathways to follow
- Opportunity to provide feedback on format, information captured
