2 NEW FEATURES IN WEMS 3.11

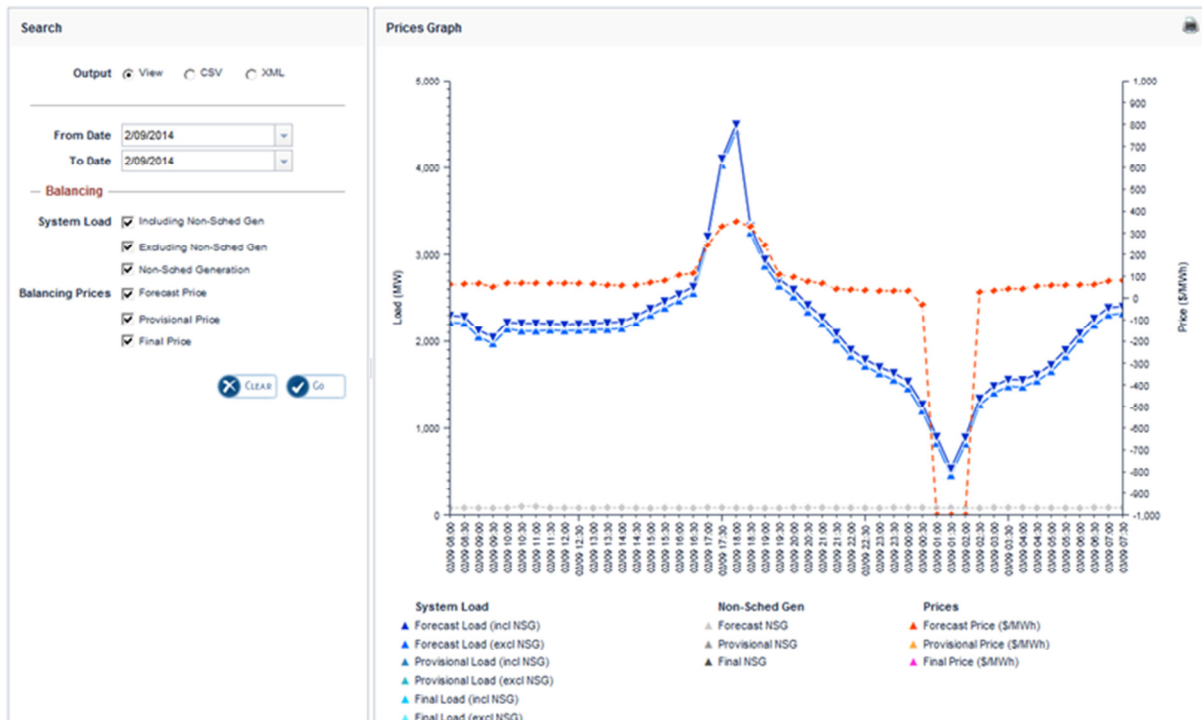
Amendments to Balancing and LFAS Price page layout.

Prior to WEMS 3.11, the Balancing Price and LFAS Price pages are actually the same page. Although the information is related, there is no discernable benefit for them to be displayed on the same graph and the extra input parameters create unnecessary complexity.

In WEMS 3.11, the Balancing Price and LFAS Price pages have been split up to improve their readability and usability. The information presented on these pages and their downloadable reports have not changed.
